## **PEDDLERS, SOLICITORS, AND DISTRIBUTORS LICENSE**

### **Instructions**

This license is required for persons seeking to sell commodities of any type and ensure compliance with the applicable Town Code regulations. Hawking and huckstering as defined by this Code is unlawful. A license or application may be revoked for cause.

### **Authority**

Denton Town Code Chapter 92, Ordinance Number 633.

### **Steps in the application process**

1. The applicant obtains an application either at the Town of Denton or on the Town website.
2. The applicant and their employees submit a completed and original application. Incomplete applications will be returned to the applicant.
3. The appropriate fee must be submitted with the application.
4. Provide two current 2-inch x 2-inch Black & White photographs, showing the head and shoulders in a clear and distinguishing manner.
5. Submit a copy of driver's license and vehicle registration.
6. Provide proof of liability insurance.
7. If serving, cooking, or warming food will be sold, or done in a vehicle, you must provide proof of Caroline County Health Department review and approval confirming food service compliance.
8. Town of Denton Planning & Code department evaluates the application for completeness.
9. The license issued **MUST** be carried at all times and displayed in a conspicuous place.
10. Licenses are valid for one (1) year.

### **Enforcement and Penalties**

Failure to obtain or violation of this permit in accordance with the Town Code is a misdemeanor. Person's aggrieved by the decision may appeal a denial of the application in writing to the Mayor and Town Council within 14 days of the denial or revocation.

### **Other requirements**

The Caroline County Health Department must inspect your equipment and vehicle whenever food is served. Contact this department at (410) 479-8049 for additional information or to schedule an appointment.
